We recently held two information sessions in the North Zone where we shared our website with caregivers while reviewing AFKA programs and services. This was an excellent way for us to share our program information, showcase our site, and highlight where to find information. The AFKA would be more than happy to do a similar thing in all the regions as it would give caregivers awareness of the resources available to them through the AFKA, their association.

The AFKA continues to be involved in discussions with the Provincial Working Group to work towards achieving consistency province-wide for caregiver recognition events. Due to COVID-19 restrictions being implemented in late September, caregiver recognition events will be mainly completed online, or with a video compilation, which will be developed and delivered by each Region. It is imperative that we continue to find ways to engage with caregivers and to ensure they feel appreciated for the critical work they do in providing a safe and nurturing home for the children and youth of our province.
